BIYA Operators would like to eliminate the long flow line from this well to the main A battery in section 34. This will reduce the possibility of line leaks. This Tank battery will be built per our SPCC requirements and we will use Best Management Practices. We will lay a layer of base at the site, laydown a 30 mil liner on base. A layer of gravel will be laid on top of liner. We will set a 300 barrel oil tank and a 210 barrel water tank on the gravel. Either a steel containment berm or an earthen containment berm will be constructed around the tanks and will be built to hold 125% of the largest tank which is the 300 Bbl tank.
