ConocoPhillips company respectfully notifies the BLM that wells on Lease NMLC068282B are shut in due to matters beyond reasonable control of the lessee. The Ramsey Gas Plant, which is owned by Western Gas Partners, LP experienced a Force Majeure event on December 3, 2015 and is currently down. ConocoPhillips has not received any guidance from Western Gas Partners regarding a possible restart date for the Ramsey plant, and is unable to speculate when the plant will be available again.
