ConocoPhillips Company respectfully requests to delay completion the well above until the end of the second quarter of 2017 due to delay of infrastructure development. The lease is currently held by shallow production by the North El Mar Unit operated by Sahara.

On May 4, the BLM and the NM State Land Office accepted a revision to the previously submitted Communitization Agreement and now the effective date is Sept. 1, 2016 with a two-year term. Accordingly, the Communitization Agreement will expire Sept. 1, 2018.
