Gentleman:

On December 19, 2013 the Farmington Field Office, Bureau of Land Management conducted a field inspection on the Schumacher #8, 990FNL & 990FEL, Section 17, T30N. R10W, lease number SF-077764 to evaluate the success of the final reclamation for this well site. According to our records this well was plugged on April 7, 1994. Conditions of Approval (COA's) attached to the approved Notice Of Intent to Abandon required that the well location and access road be reclaimed within one year of the plugging date. The results of our inspection are as follows:

- 1) No contouring of location or reclamation to access road.
- 2) No apparent disking or seeding to location.
- 3) High off road traffic on location.

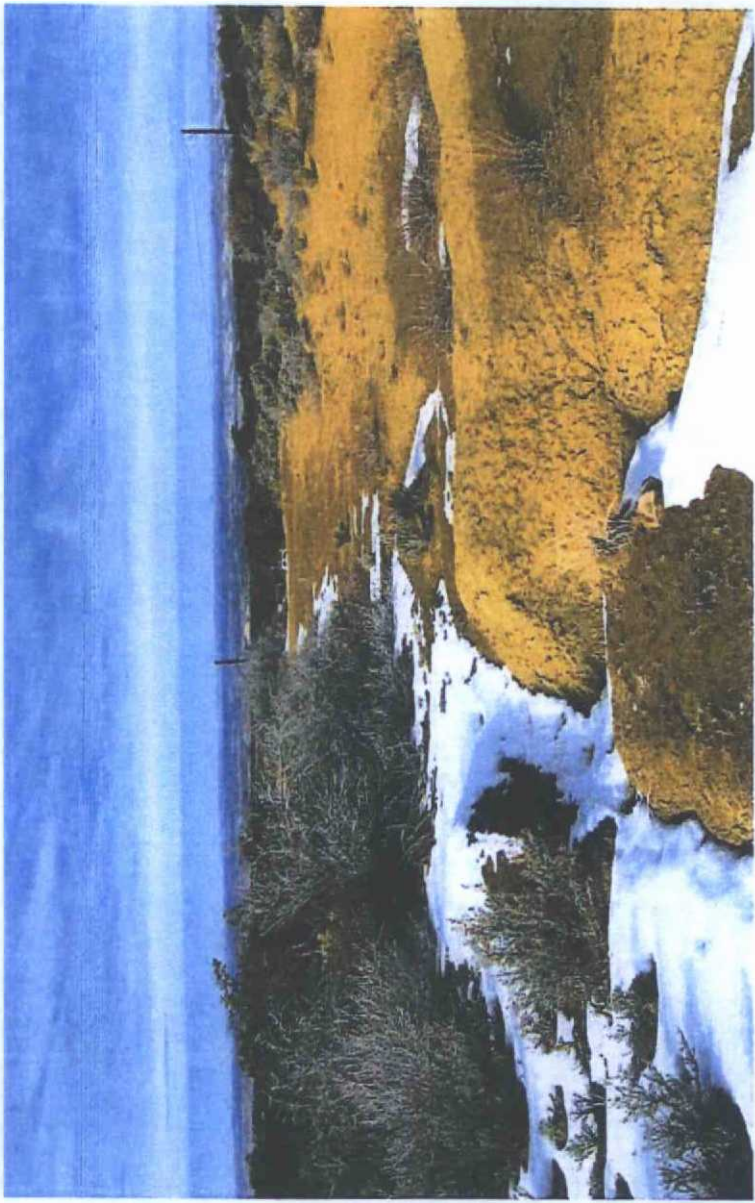


