Gentleman:

On January 7, 2014 the Farmington Field Office, Bureau of Land Management conducted a field inspection on the Bruington 1R, 1520FSL & 1120FEL, Section 20, T30N. R11W, lease number NMSF-078138 to evaluate the success of the final reclamation for this well site. According to our records this well was plugged on September 17, 2010. Conditions of Approval (COA's) attached to the approved Notice Of Intent to Abandon required that the well location and access road be reclaimed within one year of the plugging date. The results of our inspection are as follows:

- 1) Lack of desired vegetation, only Russian thistle on location
- 2) Signs of off road traffic on location.

Please notify this office after remedial actions have been performed.

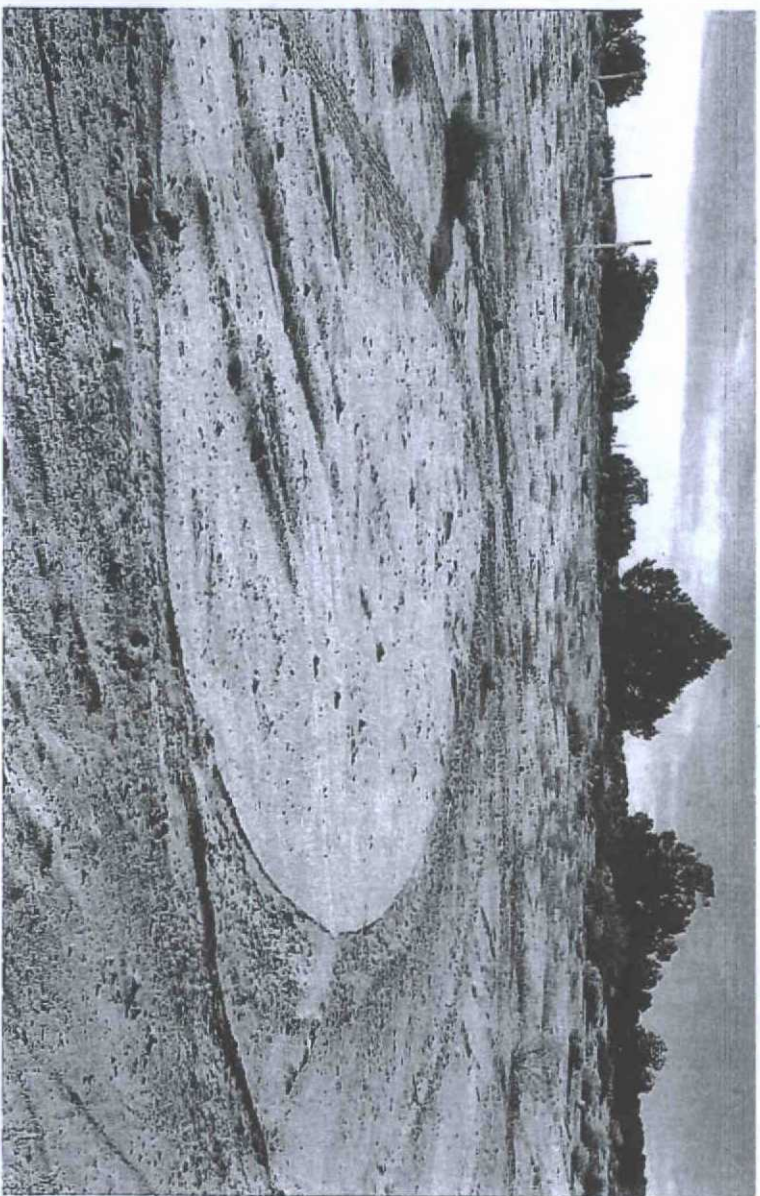
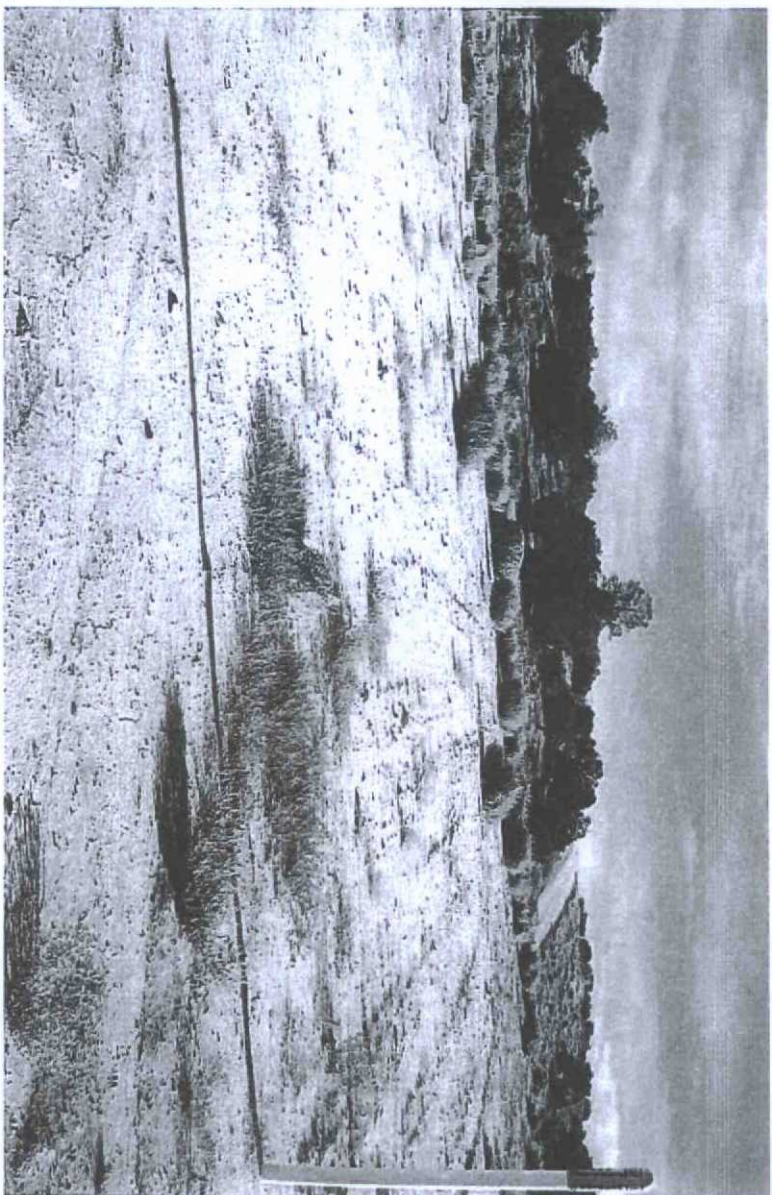
