Plugging Program for West Bisti Coal 22 Com 1

- 1) MOL RU. TOOH with 2-1/16" tubing.
- 2) TIH with 4-1/2" cement retainer and set at 1112'. Squeeze below cement retainer with 10 sx cement.
- 3) Sting out and mix and pump 90 sx cement, or sufficient volume, to bring cement to surface inside 4-1/2" casing.
- 4) Cut off well head 4 feet below surface and remediate location in accordance with regulatory agencies' conditions of approval.
