Farris Mines Plugged and Abandoned this well on May 11, 2016 per the attached report by A-Plus Well Service.

Plug #1 with 48 sxs (56.64 cf) Class B cement from 348' to surface circulate good cement out 5-1/2" casing. Tag TOC at 25'.

Plug #2 with 10 sxs Class B cement top off casings and install on P&A marker with coordinates N 35° 47' 4" W 107° 56' 6".

5/10/16 Rode rig and equipment to location. RU and SDFD. Travel back to A-Plus yard.

5/11/16 Travel to location. Open up well; no pressures. X-over to rod tools. Attempt to unseat pump, unable to unseat pump. PU on tubing and slips. Well had old tubing head, tubing 2-1/16" IJ. Strip off tubing head and strip on 5-1/2" x 8-5/8" tubing head and 8-5/8" companion flange. Strip on BOP. Strip out 2-1/16" tubing using 2-1/16" x 2-3/8" x-over and 3' 2-3/8" sub. LD 1 - 12" sub, cut 5/8 rod with hacksaw, LD 10 jnts 2-1/16" with rod pump, 1-8' MA using same method. Round trip 5-1/2" A-Plus string mill to 352' and tag. Circulate well clean. TOH with tubing. Spot plug #1 with TOC at surface. ND BOP and companion flange and tubing head. RD rig. Dig out wellhead. Cut off wellhead. Tag TOC down 25' in 5-1/2" casing. Spot plug #2 top off casings and install on P&A marker with coordinates N 35° 47' 4" W 107° 56' 6".
