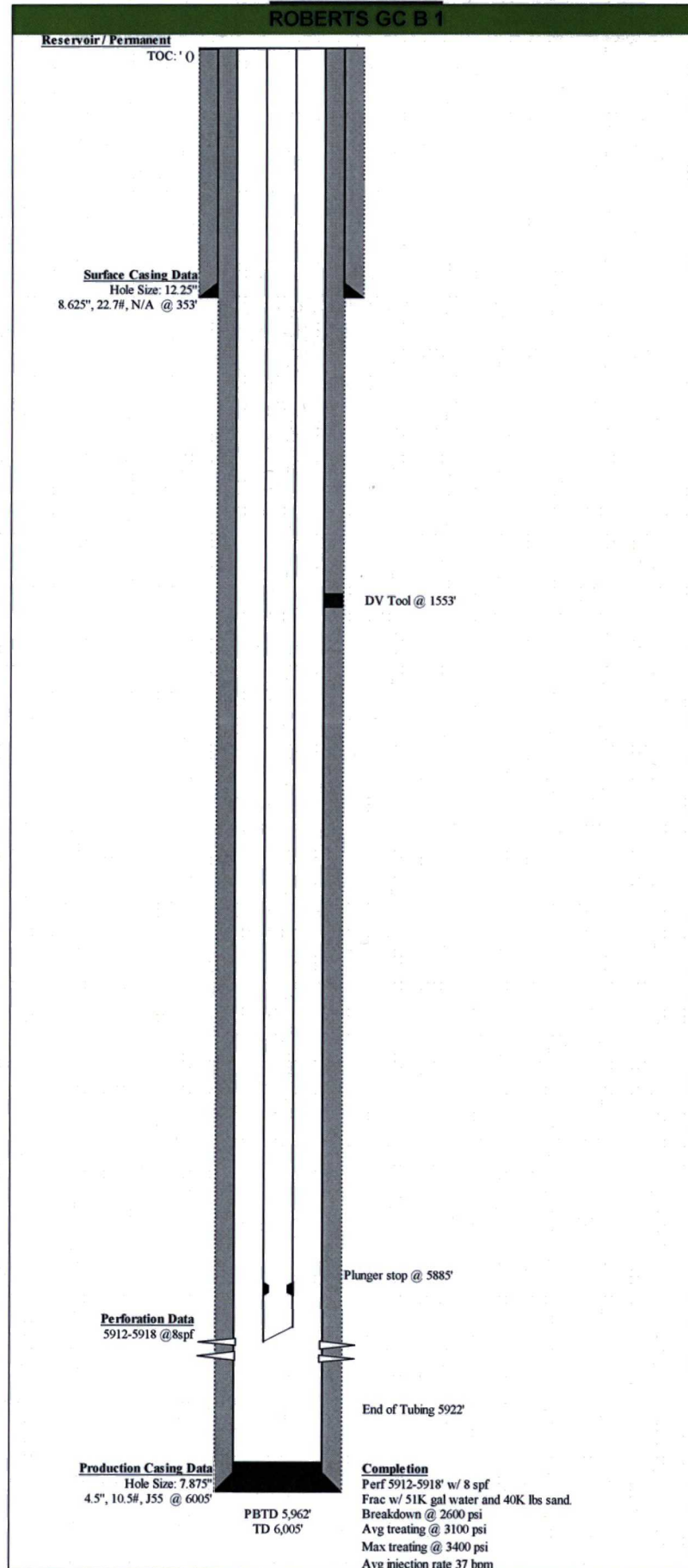
The proposed work is to pull the current completion, add perforations, refrac the Dakota formation, install artificial lift, and return the well to production.

4. Cleanout to 6000'
5. Run production tubing
6. Run pump and rods
7. Return well to production


