Describe Cause of Problem and Remedial Action Taken.*
Leak occurred at the wellhead. The leak was stopped and stuffing box tightened. A water truck was called to the location. The water truck recovered 5 bbl produced water from cellar and on location.

Describe Area Affected and Cleanup Action Taken.*

- A water truck recovered 5 bbl of produced water.
- Majority of the released produced water remained within wellhead cellar, all released produced water remained on location.
- On October 6, 2016, one 5-point composite sample (SC-1) was collected from within the impacted area. The sample was analyzed for TPH (GRO/DRO), BTEX, and chlorides. Cory Smith, NMOCD, was present during sample collection.
- Confirmation sampling results were reported below NMOCD action levels, no further action is required. (Laboratory analytical report is enclosed.)
