 - ✓ A closed loop system requires notification prior to use, pursuant to 19.15.17.9.A

- ✓ Once the well is spud, to prevent ground water contamination through whole or partial conduits from the surface, the operator shall drill without interruption through the fresh water zone or zones and shall immediately set in cement the water protection string
- ✓ Submit Gas Capture Plan form prior to spudding or initiating recompletions operations.
- ✓ Regarding Hydraulic Fracturing, review EPA Underground Injection Control Guidance 84
