We will be moving heavy equipment onto the Jones A LS 002-MV well pad in order to perform fracture stimulation operations. Heavy equipment includes approximately 3 fluid pumps, 5-6 nitrogen transports, 4 nitrogen pumps, 4-5 water tanks, 1 flowback tank, blender, sand chief, CAS unit, treating van, and associated flow iron. Most heavy equipment will be on location for 1-2 days to perform the fracture operation and then moved off immediately. Water tanks will be moved onto location 1-2 weeks prior to the frac date and removed following the fracture operation. The flowback tank will remain on location 1-2 weeks following the frac date and will be removed once post-frac wellwork is completed with a service rig. Any disturbance/leveling needed for the heavy equipment will be kept within the original pad and the location will be re-seeded/reclaimed to pre-frac size following the post-frac workover.
