XTO Energy Inc. received verbal approval on 11/02/16 from Brandon Powell/NMOCD @ 4pm and 11/03/16 from Troy Salyers/BLM @ 11am to perform a casing repair on this well. We plan on setting a CIBP below the leak and squeeze using a cement retainer set ~50' above the leaking interval. The plan is to pump 150 sks cement (100 sks neat and 50 sks with 2% CaCl₂ on the side). After letting the cement set for 24 hrs, we'll drill out to CIBP and test casing (MIT) to 550 psig and chart it.
