NO CEMENT WILL BE PLACED UPON CIBP AT THE PRESENT TIME, SINCE WELL PLAN IS TO RETURN WELL TO PRODUCTION.

PERFORM WITNESSED PRESSURE TEST AND SUMBIT CHART WITH SUBSEQUENT SUNDRY NOTICE.
