The Gallegos Canyon Unit 227 well API 30-045-11624 was plugged and abandoned on 6/9/2004. As of 7/27/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 8, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
