The Hughes LS 016 well API 30-045-11750 was plugged and abandoned on 6/8/2004. As of 8/10/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 1, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.

During the site visit it was noted that an Enterprise Riser remains on location and needs to be removed. On 12/7/2016 Sarah Clelland with Enterprise was contacted via email that this riser is needing to be removed from location and that reclamation work has been completed as of 8/10/2016. The removal of this is to be scheduled.
