The Gallegos Canyon Unit 012 well API 30-045-07089 was plugged and abandoned on 2/21/2005. As of 6/28/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 8, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.

Note During site visit an Enterprise riser was identified that needs to be removed. BP notified Sarah Clelland at Enterprise of this riser and the need to remove it on December 8, 2016 and was told the removal will be scheduled.
