The Gallegos Canyon Unit 076 well API 30-045-07277 was plugged and abandoned on 3/30/2010. As of 11/15/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.

NOTE: During site visit a dog leg belonging to Enterprise was identified. BP contacted Enterprise regarding this dog leg and was informed that this dog leg is still in service of 2 active wells and must remain at this time.
