The Gallegos Canyon Unit 003 well API 30-045-07300 was plugged and abandoned on 7/30/2004. As of 11/2/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.

NOTE: During site visit on 12/20/2016 it was identified that an Enterprise riser remains on location that needs to be removed. On 12/20/2016 Sarah Clelland with Enterprise was notified by BP that this riser needs to be removed from location.
