The Gallegos Canyon Unit 242 well API 30-045-11736 was plugged and abandoned on 6/8/2004. As of 11/2/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
