The Gallegos Canyon Unit 277 well API 30-045-23602 was plugged and abandoned on 6/27/2006. As of 12/7/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.

NOTE: During the site visit a dog leg belonging to Enterprise was identified. BP contacted Sarah Clelland with Enterprise regarding this dog leg and was informed that this still serves the GCU 346 and must remain on location.
