On December 20, 2016 Randy McKee (BLM) and Sabre Beebe (BP) performed a site visit on the GCU 368 location, which had been re-contoured to the extent it could be without impacting the twinned location active BP well GCU 083E API 30-045-26011. During this site visit it was noted the fill dirt to reclaim active well GCU 083E is part of the reclaimed well pad for the GCU 368. Therefore when the GCU 083E well is plugged, the reclamation work performed on the GCU 368 will be significantly impacted in order to obtain re-contouring of both well pads.

Mr. McKee and BP concur the GCU 368 Final Abandonment Notice shall be approved with the final reclamation responsibility being shifted to the GCU 083E when that well is plugged and abandoned.
