BP recently requested approval to temporarily use gas produced from well(s) within the Northeast Blanco Unit as fuel gas to provide power for a natural gas-fired drilling rig. As requested by the BLM's Michael Porter regarding the line and use, please note the pipeline will be placed within the construction zone. It will take gas from downstream of NEBU 213 Meter (currently a 2" line) from the BP Middle Mesa pipeline gathering system. BP will construct a 2" above ground steel line from this tie-in point and install an associated meter. The meter shall be connected to BP's automation system to provide measurement data. The fuel line will be within the construction area and NEBU 602 pad in order to provide natural gas to drilling rig Gensets. The line is temporary and shall be removed immediately following completion of drilling operations.
