The Gallegos Canyon Unit 007 well API 30-045-07212 was plugged and abandoned on 9/27/2000. As of 6/30/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 8, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation. During site visit it was discovered that an Enterprise riser was on location that needs to be removed. On December 8, 2016 Sarah Clelland with Enterprise was advised of the riser and the need to remove it. BP has been told this will be scheduled to be removed by Enterprise.
