Plug and Abandonment Report
Notified NMOCD and BLM on 12/14/16

Plug and Abandonment Summary:

- Plug #1** with 160 sxs (188.8 cf) Class B cement from 2800' to surface at 96 sxs caught pressure slowed pump down shut in well at 160 sxs with 78 sxs inside and 82 sxs outside. Tag TOC at 595'.
- Plug #2** with 26 sxs (30.68 cf) Class B cement from 595' to surface to cover the casing shoe and surface.
- Plug #3** with 14 sxs Class B cement top off with poly pipe and install P&A marker with coordinates N 36° 30' 24" / W 107° 41' 3".

Plugging Work Details:

- 12/16/16 Rode rig and equipment to location. Spot in and RU. Check well pressures: tubing and casing 300 PSI, bradenhead 0 PSI. Blow well down. ND wellhead. NU A-Plus B-1 adapter. NU BOP. X-over to 1-1/4" tubing equipment. Pressure test bradenhead to 300 PSI, OK. LD 87 jnts 1-1/4" EUE on gooseneck trailer, total tally 2756'. ND BOP and B-1 adapter. **Spot plug #1** with TOC at surface. SI well. SDFD.
- 12/19/16 Open up well; no pressures. Attempt to tag TOC with tally tape, no tag 100'. NU BOP. TIH and tag TOC low at 595'. Dig out wellhead. **Spot plug #2** with TOC at surface. TOH and LD all tubing. ND BOP. Write Hot Work Permit. Cut off wellhead. Found cement down 30' in 2-7/8" and down 37' in 2-7/8" x 7". **Spot plug #3** top off with poly pipe and install P&A marker with coordinates N 36° 30' 24" / W 107° 41' 3". RD and ready equipment for move. SDFD.
- 12/20/16 Travel to location. Move equipment to A+ yard.
