Cement w/160 sks, 220 cu ft Halliburton Halcem cement blend (13.5#/gal, 1.38 cu ft/sk, 5.85 gal/sk mix water - Class G w/50% poz, 1% bwoc bentonite, 5 lb/sk Kol-seal, 0.125 lb/sk Pol-E-FLake, 0.1% bwoc CFR3 and 2% CaCl2). Total cement volume 220 cu ft, 39.3 bbls. Displace w/15.5 bbls water. Circulated 10 bbls cement to surface. D&D Rig #1 released 4/28/17. Pressure test to be reported on completion sundry. ✓
