WPX Energy requests a **continued** authorization to flare the **W Lybrook Unit #749H** if a potential cross flow event may occur as a result of a nearby Frac activity on **W Lybrook 750H-751H-752H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **6/20/17 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
