RIH w/234 jts 2 3/8", 4.7#, J-55 tbq set @ 8173'. 6/15/2017 PT 3 1/2" csg to 640#/35mins. Test - OK. ND annular & BOP. NU WH. RIH w/retrieval tool to 8163', sheared off plug. TOOH RIH w/retrieval tool to 8163' recovered X-Plug. Pumped 170bbbs fresh water into tbq. 6/16/2017 RD RR @ 9:30hrs.
