Elm Ridge Exploration LLC, Co. has cut off the wellhead, installed dryhole marker, and completed the reclamation on the above referenced well as of February 21, 2007. Randy McKee the Inspector for the Bureau of Land Management and Amy Archuleta, Regulatory Supervisor for Elm Ridge conducted and onsite evaluation of this plugged well on 7-25-17. The Federal 35-43 well shares a pad with the Federal 35-43R (30-045-31954) and we agreed this well will hold the reclamation responsibility once it is plugged. We request the Federal 35-43 be released for Final Abandonment.
