Cement with 250 sks Class B, 2% CaCl₂, 1/2#/sk floccle (295 cu.ft.). Plug down @ 2:15 pm on 03/18/06. Circulate 5 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
