WPX Energy requests authorization to flare the W Lybrook Unit #710H if a potential cross flow event may occur as a result of a nearby Frac activity on W Lybrook Unit #716H-718H-719H-753H-754H-755H. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as 10/7/17 for 30 days, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
