The well will be re-evaluated yearly based on economic and operational considerations. XTO Energy has a long term shut-in compliance agreement with the NMOCD (ACOI No. 2017-002) dated 08/02/2017.

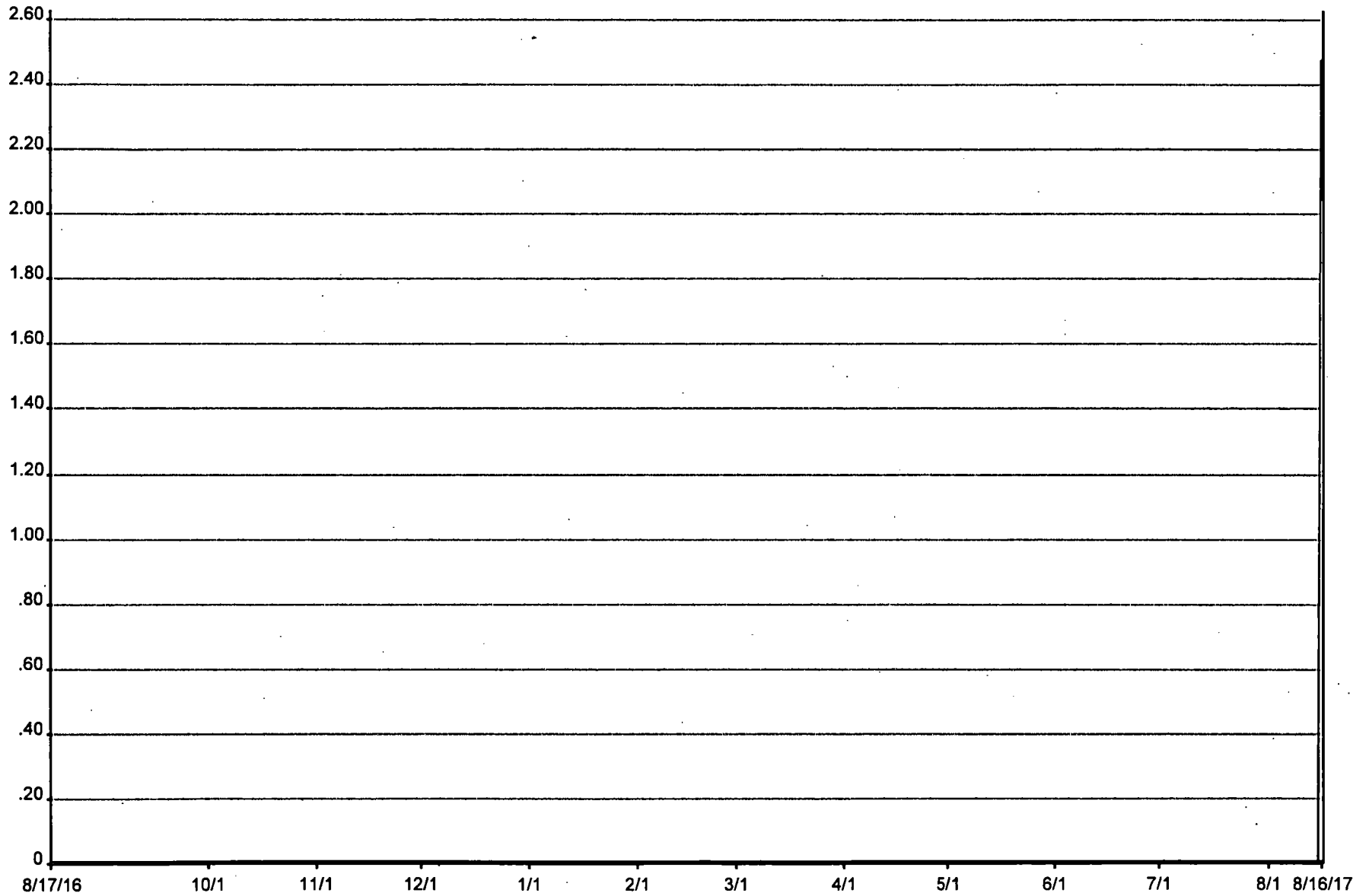

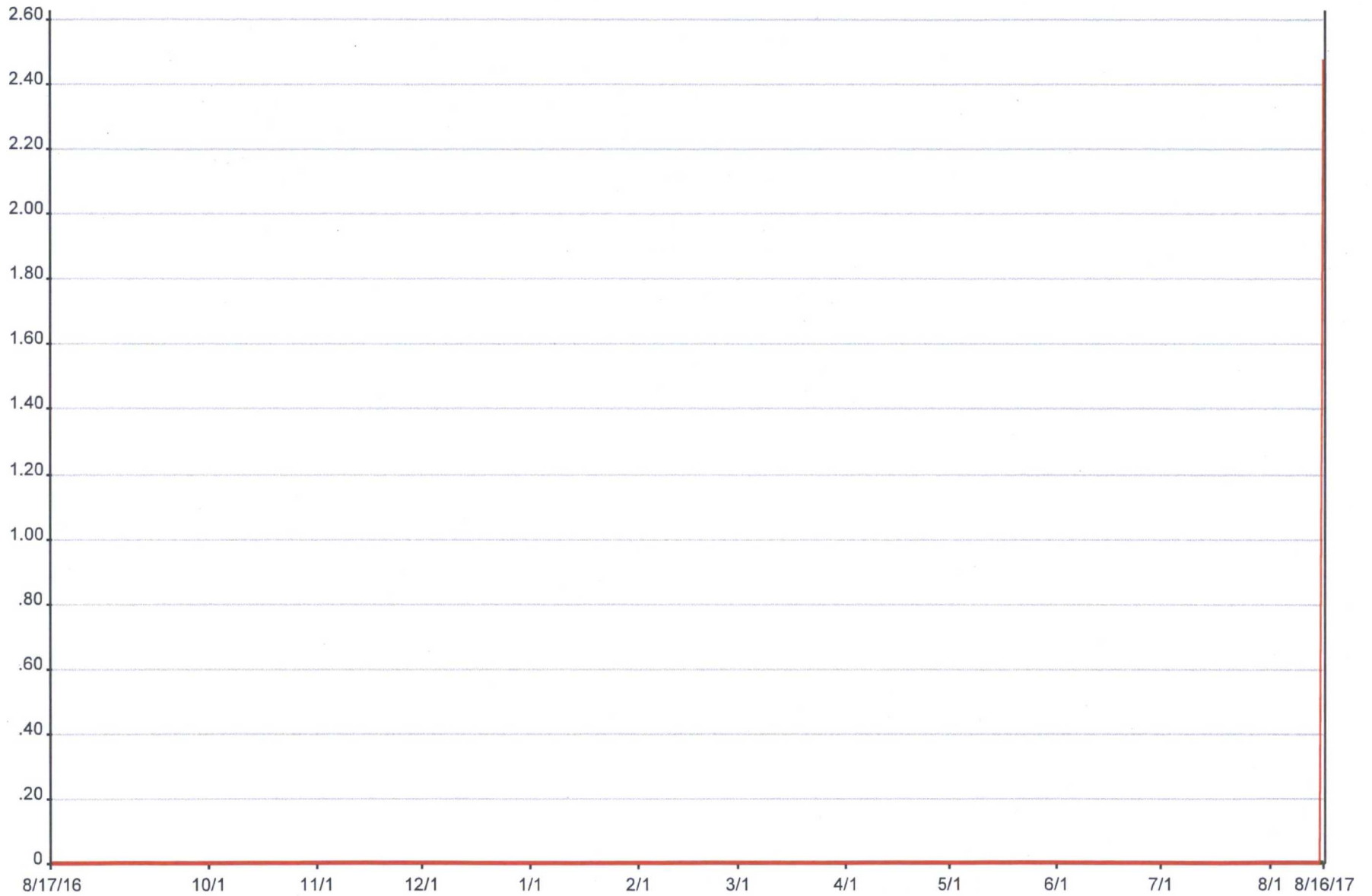
