

Mesa Verde Uphole Recomplete

2/1/2018

Procedure:

1. MIRU Service rig and associated equipment, test BOP.
2. TOOH w/ 2 3/8" tubing set at 7,732'.
3. Run gauge ring and set 4.5" bridge plug to isolate the Dakota.
4. Load the hole and pressure test to frac pressure.
5. ND BOP, NU frac stack and test frac stack to frac pressure.
6. Perforate and frac the Mesaverde, isolating frac stages w/ frac plugs. (Proposed top perf at 5,050', proposed bottom perf at 5,975')
7. TIH w/ mill and drill out Mesaverde frac plugs.
8. Clean out to Dakota isolation plug and when water and sand rates are acceptable, flow test the Mesaverde.
9. Drill out Dakota isolation plug and cleanout to PBTD of 7,887'. TOOH.
10. TIH and land production tubing. Get a commingled Dakota/Mesaverde flow rate.
11. Release service rig and turn well over to production.
