The well pad was found to be stable and have met all reclamation requirements for FAN. Enterprise equipment was remaining on the edge of the well pad. Enterprise needed to provide a justification letter for leaving this piping on the edge of location which was approved on January 9, 2018 by BLM Reality Department. This approval allows for BP to receive a FAN on the Florance 087 reclamation and release on this well pad.
