1. MIRU Service rig and associated equipment, test BOP's
2. TOOH w/ 2-3/8" tubing string set at 4,575'
3. Run Gauge ring and set 7" bridge plug above current Pictured Cliffs perfs
4. If necessary, run frac string
5. Pressure test to maximum frac pressure
6. ND BOP & NU frac stack & test to frac pressure
7. MIRU frac spread
8. Perforate and frac the Fruitland Coal (Proposed top perf at 1,860', proposed bottom perf at 2,137')
9. RDMO frac spread
10. MIRU Service rig and associated equipment, test BOP's
11. If frac string was necessary, POOH w/ frac string
12. RIH w/ mill and clean out to top of Pictured Cliffs Isolation plug
13. Clean out until water and sand rates are acceptable
14. Drill out Pictured Cliffs isolation plug and cleanout to PBTD. TOOH
15. TIH and land production tubing
16. RDMO service rig and turn well over to production


