



VALVES DURING PRODUCTION

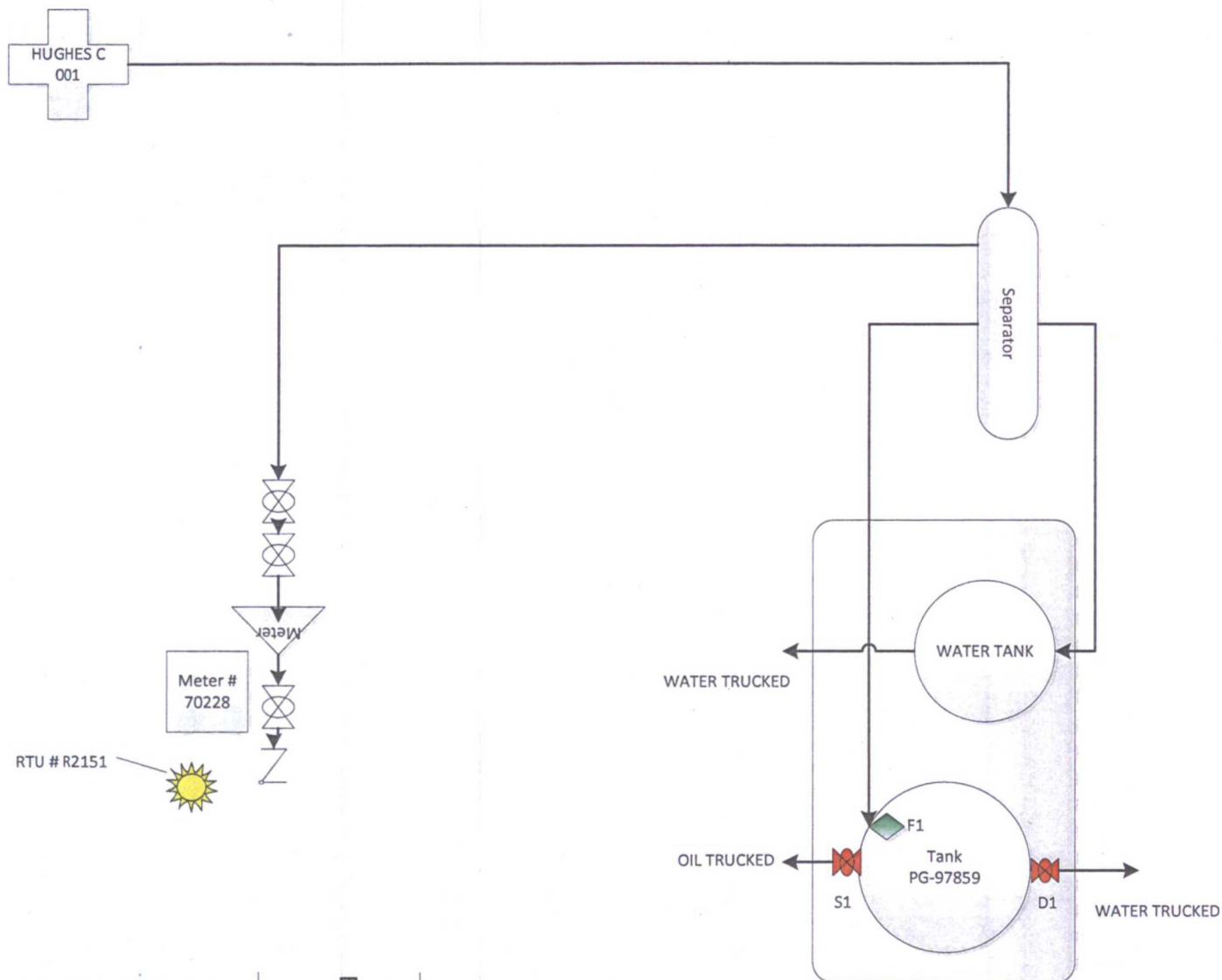
