

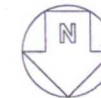



VALVES DURING PRODUCTION

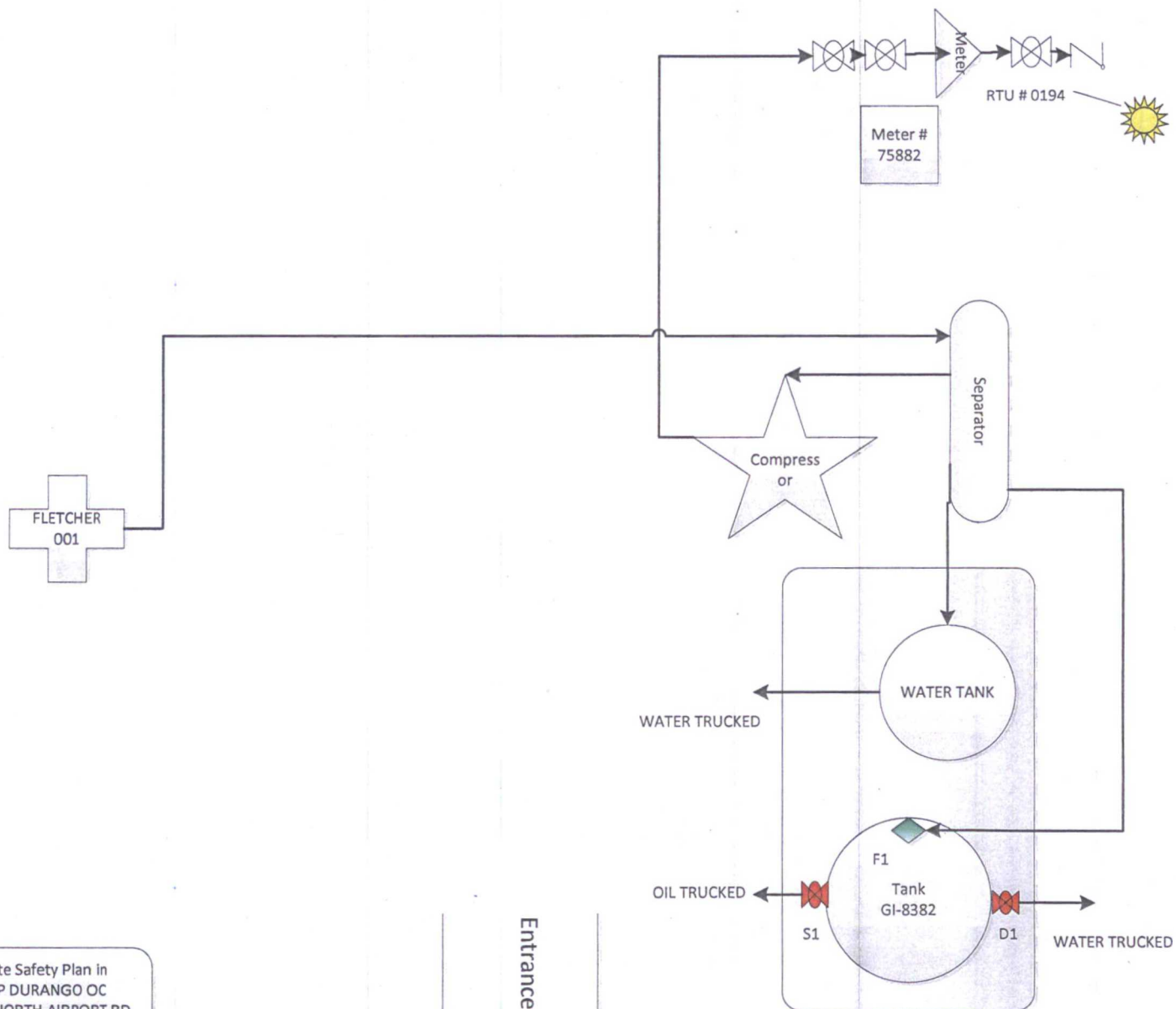
