BIYA Operators, Inc. respectfully requests permission to set a tank battery at the HGU 209 oil well. This proposed tank battery will eliminate long flow lines to existing tank battery at the HGU 185. This tank battery will be built per our SPCC requirements and we will use BMP. We will lay a layer of base at the site lay down a 30 mil liner on the base. A layer of gravel will be laid on top of the liner. We will set one 300 bbl tanks. An earthen containment berm will be built around the tanks and the berm will be built to hold 125% of the volume of a 300 bbl tank.
