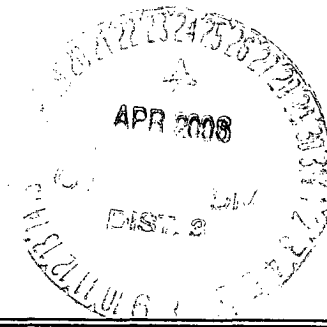

Cement with 225 sks Class B, 2% CaCl2, 1/4#/sk floccle (266 cu.ft.). Plug down @ 8:00 am on 04/16/06. Circulate 15 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing 7 BOP to 600 psi - ok.
