05-08-18: Rig up Basin Energy and acidize perfs with 6800 gallons 7.5% DI, MCI acid with 5% Musol, iron sequestering, clay stabilizer, friction reducer, and flowback surfactant 05-11-18: Fracture as follows: Pumped 4,000,000 GALLONS OF FLUID BY 16,000 gals of 50Q foam. 70,000 gals of 70Q foam. Pumped 200,000 lbs of 20/40 RESIN sand.

05-14-18: Put well on 34/64" choke w/ 41% oil cut. First deliver well to Enterprise Products Company

05-22-18: Set 2 3/8" 4.7# J55 production tubing at 6997'. 05-24-18: Release Rig from location

05-28-18: Test well production.
