BP previously obtained an extension to delay running tubing until May 19th 2018. Based on our current forecast, the well production will not reach the tubing constrained rate until August 2018.

As a result, BP requests to delay running tubing until August 19th, 2018 in order to continue data collection at rates higher than what is possible through tubing.
