This sundry notice is being submitted by Enduring Resources as a follow-up to their vegetation monitoring of the subject well, in accordance with the BLM-FFO Bare Soil Reclamation Procedures for an on-lease well pad. This well's well pad has met the vegetation standards outlined by its designated vegetation community and is recommended to be moved into a five-year monitoring schedule. The vegetation monitoring for this well took place on 6/27/17. The well pad sits within Pinyon Juniper habitat and requires a vegetation cover of 20% or greater. After monitoring this pad, the results show that this pad had 28% cover on transect one (1) and 25% cover on transect two (2) with an average of 26.5%.
