

This sundry notice is being submitted by Enduring Resources as a follow-up to their vegetation monitoring of the subject well, in accordance with the BLM-FFO Bare Soil Reclamation Procedures for an on-lease well pad. This well's well pad has met the vegetation standards outlined by its designated vegetation community and is recommended to be moved into a five-year monitoring schedule. The vegetation monitoring for this well took place on 7/19/17. The well pad sits within sagebrush habitat and requires a vegetation cover of 35% or greater. After monitoring this pad, the results show that this pad had 46% cover on transect one (1) and 57% cover on transect two (2) with an average of 51.5%.
