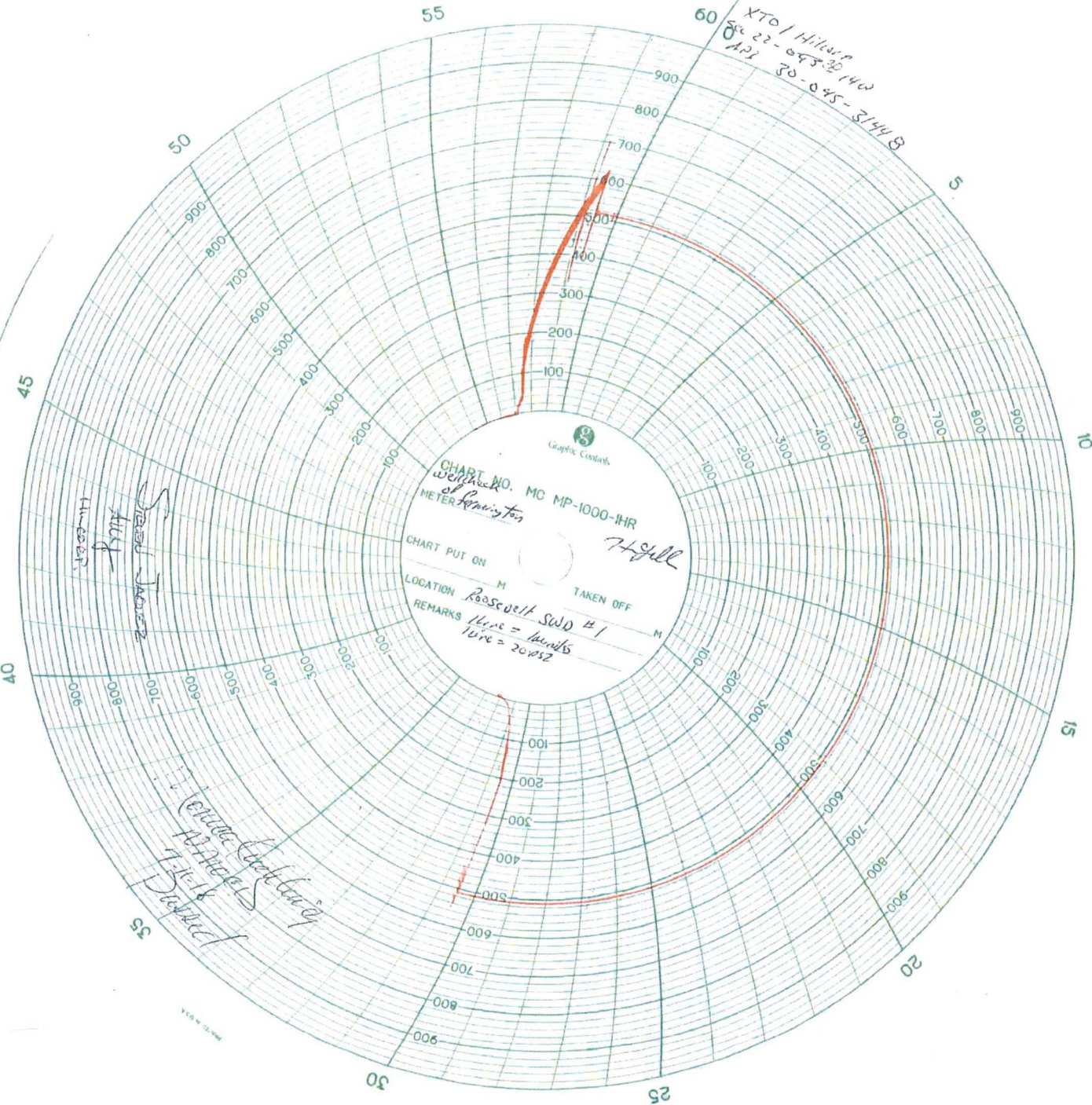


CHART NO. MC MP-1000-IHR
