Tacitas, LLC intends to drill out the CIBP that was set at 6449' (inside the 7" casing) and clean out with air/mist to the top of the drill collars (fish) that were left in the open hole during the last drill out operations. Will attempt to clean up the hole with air/mist and if results are positive plan to run a packer on 2-3/8" and land at the bottom of the 7" casing (~ 6486') and test open hole section for Helium production.
