MIRU drilling unit @ 9:00 on 8/16/18 & spud a 8-3/4" surface hole. Drilled to 241'. RU and ran 7" 20# K-55 CSG to 223'. Cement w/ 161 sx Class G cement @ 15.8 ppg; Yield 1.150 cu-ft/sx. Displaced 9.0 bbls water circ. Circulated 15 bbls of cement to surface. Dropped plug and bumped plug at 749 psi, shut-in pressure was approximately 750 psi. WOC 12 hours. N/U BOP @ manifold/test all valves to 600 psi against surface casing. All valves ok. ✓
Received variance from BLM to test against casing to 600 psi. ✓

Drill out CMT. Drilled a 6-3/4" hole to 729'. RU and ran 4-1/2" casing, 11.6# P-110 to 723'. CMT 4-1/2" csg w/ 115 sx Class G cement @ 15.8 ppg; Yield 1.15 cu-ft/sx. Circulated 2 bbls of cement to surface. Dropped plug and bumped plug at 1100 psi. Last pressure and rate observed was 670 psi @ 2 bbls/min.
