
Enduring Resources inadvertently drilled the **S ESCAVADA UNIT 352H (30-043-21323) & S ESCAVADA UNIT #353H (30-043-21320)** from an incorrect surface hole location. The 352H well was drilled from the permitted surface hole location for the 353H well and the 353H well was drilled from the permitted 352H surface location. The surface location is the **ONLY** discrepancy from the approved APD's and the remaining portions of each well is drilled as approved. This discrepancy is simply a 20 foot difference at the surface location and we request to correct the surface hole latitude and longitude for each well respectively. Attached are updated As Drilled C102's.

From the intersection of US Hwy 550 & US Hwy 64 in Bloomfield, NM, travel Southerly on US Hwy 550 for 48.9 miles to Mile Marker 103.1;

Go Right (Southerly) on Atkins Road for 5.9 miles to 4-way intersection;

Go Straight (Southerly) remaining on Atkins Road for 1.9 miles to fork in roadway;

Go Left (Southerly) which is straight remaining on Atkins Road for 0.7 miles to begin new Enduring S Escavada Unit #350H proposed access on left-hand side of existing roadway;

Go Left (Southerly) which is straight following along proposed WPX S Escavada Unit #350H access for 2467.4' to fork in proposed roadway;

Go Left (Easterly) continuing for an additional 2729.7' to staked Enduring S Escavada Unit #352H location.
