

JOB PROCEDURES

1. MIRU service rig and associated equipment; test BOP.
2. TOOH with 1.66" tubing set at 7,881'.
3. Set a 4-1/2" cast iron bridge plug at +/- 6,000' to isolate the **Dakota**.
4. Load the hole run a CBL from the CIBP to Surface.
5. Pressure test the casing.
6. N/D BOP, N/U frac stack and test frac stack to frac pressure.
7. Perforate and frac the **Mesa Verde** (Top Perforation @ 5,100'; Bottom Perforation @ 5,960').
8. Nipple down frac stack, nipple up BOP and test.
9. TIH with a mill and drill out top isolation plug and **Mesa Verde** frac plugs.
10. Clean out to **Dakota** isolation plug.
11. Drill out **Dakota** isolation plug and cleanout to PBTD of 7,953'. TOOH.
12. TIH and land 2-3/8" production tubing @ 7,881'.
