On 12-13-18, Robert Switzer of the BLM-FFO and Paul Lehrman of DJR Operating, LLC visited the site. The site has had all surface equipment removed (Pumping Unit, Separator, Meter Run and all above ground facilities associated with the well, along with any underground facilities within the well pad boundaries.

The site has been re-contoured, reseeded and all other specified requirements per the Reclamation Plan as approved by the BLM-FFO.

Per Robert Switzer, BLM-FFO AO, the site has been found to comply with the interim requirements under the BLM guidelines and the Reclamation Plan.

Final Reclamation/FAN will be forthcoming as the site meets BLM final reclamation vegetation standards.
