Pumped tail cement 37.8bbls (180 sk)** Dropped plug & began displacement. Displaced with 206.0. bbls FW. Slowed rate to 3 BPM for last 20 bbls. Plug bumped f/ 850 psi Floats Hold Pressure Up to 1,250 and Hold. Maintained returns throughout job and **circulated 81 bbls got 80 bbls of good cement to surface.**
