The A. L Elliott B 004 well plug and abandonment was completed on 5/29/2012. This well location underwent full reclamation work. On August 30, 2017 BLM Representative Randy McKee and BP Representative Sabre Beebe visited the location to discuss Final Abandonment completion. All reclamation meets BLM requirements for Final Abandonment. Mr. McKee concurred that the location meets BLM requirements for FAN on the 30th. Therefore, BP is requesting final approval of FAN on the A. L. Elliott B 004 well pad.
